## ERA releases 2018 Sustainability Report

Energy Resources of Australia Ltd (ERA) has today released its Sustainability Report for the year ended 31 December 2018.

The Sustainability Report summarises ERA's performance in regard to key safety, environmental, community engagement and workforce diversity objectives.

ERA's Chief Executive Paul Arnold said: "This Sustainability Report reflects the commitment of ERA to care for country and people. ERA has a strong record of protecting the environment surrounding the mine and we are demonstrating good progress toward rehabilitation of the mine site even as operations continue."

"I am proud to acknowledge the contribution of everyone at ERA towards these outcomes. It is only with the support of our people that these outcomes are made possible." Mr Arnold said.

Mr Arnold noted that the diversity of the ERA team is a key strength for ERA, in particular the above industry average for Aboriginal and female employee participation. Diversity is an area in which the Company always strives to do better.

Mr Arnold also expressed the Company's appreciation for the support received from the Mirarr, Traditional Owners of the land on which the Ranger mine is located, especially in respect to driving toward a future for Jabiru and endorsement of the Ranger Mine Closure Plan.

Some of the key achievements highlighted in the 2018 Sustainability Report include:

- 13% Aboriginal and Torres Strait employment;
- All Injury Frequency Rate of 0.56 in 2018 compared to 1.17 in 2017;
- \$10.7 million paid in royalties (over \$500 million since production commenced);
- \$100 million contributed to Jabiru through salaries and local spend;
- Public release of the Ranger Mine Closure Plan; and
- \$59 million invested in Ranger rehabilitation (\$511 million since 2012).
