ERA releases Sustainability Report

Energy Resources of Australia Ltd (ERA) has today released its Sustainability Report for the year ended 31 December 2020.

The Sustainability Report summarises ERA's performance in regard to key safety, environmental, community engagement and workforce diversity objectives.

ERA's Chief Executive Paul Arnold said: "This Sustainability Report reflects the continued commitment of ERA to care for people and country. ERA has a strong record of protecting the environment surrounding the mine and following our transition from processing operations to full-time rehabilitation, our strategic objective is to restore the Ranger Project Area to meet the expectations of Traditional Owners and to satisfy our regulatory obligations in full."

"I am proud to acknowledge the dedication and unrelenting focus of our team as we worked through the COVID-19 pandemic to protect our people and the local community as our first priority.

"I would also like to thank the entire ERA team for their continued commitment as we now pivot to focus on the critical work of full-time rehabilitation activities at Ranger," Mr Arnold said.

Mr Arnold also expressed the Company's appreciation for the support and engagement received from the Mirarr, Traditional Owners of the land on which the Ranger mine is located.

Some of ERA's key achievements highlighted in the 2020 Sustainability Report include:

- Successful completion of its \$476 million entitlement offer to fully fund the comprehensive rehabilitation of the Ranger Project Area
- \$80 million spent on rehabilitation activities throughout 2020
- Planted 1248 native plants and commenced planting the final landform (stage 13)
- Backfill of Pit 1 completed ahead of schedule in August 2020
- Completed 65,000 COVID pre-screening and temperature checks during the year
- Actively donated sanitisers and cleaning products throughout Jabiru and West Arnhem during the COVID-19 pandemic to help protect local communities
