ERA releases Ranger Mine Closure Plan update

Energy Resources of Australia Ltd (ERA) has released an update to the Ranger Mine Closure Plan.

This release of the updated Mine Closure Plan follows the inaugural public release of the Mine Closure Plan in June 2018. The Plan is updated annually in consultation with Traditional Owner representatives, regulators and key stakeholders.

ERA's Chief Executive Paul Arnold said: "ERA is committed to fully rehabilitating the Ranger Minesite to the highest standards. Through the application of leading expertise, practice and technology, as outlined in the Mine Closure Plan update, ERA aims to achieve best-in-class closure outcomes."

Mr Arnold explained: "Since 2012, ERA has spent more than \$559 million on rehabilitation and water management. With completion of the Ranger Project Area closure feasibility study in February this year, ERA has a consolidated, executable plan to be implemented over the next six to seven years, making this one of the Northern Territory's major projects."

"The quality of the Plan reflects the efforts of a passionate and capable team at ERA as well as the valued feedback from our stakeholders including the Gundjeihmi Aboriginal Corporation, the Northern Land Council, the Supervising Scientist Branch, and Northern Territory and Commonwealth regulatory agencies."

"The rehabilitation process is complex and extensive and this is reflected in the substantial detail contained in the Mine Closure Plan. To provide a brief, visual overview of the Plan, ERA has produced an animation in consultation with the Gundjeihmi Aboriginal Corporation which shows the progressive rehabilitation of the Ranger Minesite. It's a great tool which breaks down the rehabilitation process into easily understood concepts, provides a timeline for the works to be carried out, and has a narration in local Kunwinkju language.

"In addition to the release of the Mine Closure Plan update released today, we are also sharing a story of our collaboration with Kakadu Native Plants, an indigenous local business and their important work of harvesting seeds and raising seedlings which will be used to revegetate the Ranger mine. More than 1 million trees will be planted as part of the revegetation of the Minesite." Mr Arnold said.
