Update on leach tank incident at Ranger mine

10 December 2013

The clean-up operation at Energy Resources of Australia's Ranger mine is now well-advanced.

ERA Chief Executive Andrea Sutton said "This is a serious issue and we are confident that we have the technical expertise to manage the incident.

"We acknowledge the appointment of a Government taskforce to oversee the regulatory response to this incident. Representatives from each of the taskforce members have visited site and we are working with them."

Monitoring at Ranger mine has shown there has been no impact on employees and the surrounding environment following the failure of a leach tank on Saturday 7 December 2013.

The monitoring has shown radiation dose levels are well within safe daily limit levels and continuous water quality monitoring has confirmed creeks and billabongs surrounding Ranger Mine have not been affected.

The leach tank incident released slurry in the site's processing area, but the release was fully contained onsite with no impact to the environment or to Kakadu National Park. ERA voluntarily shut down its processing operations at Ranger after the incident and notified Government authorities and key stakeholders.

General Manager Operation Tim Eckersley said the company is also conducting its own investigation.

"ERA will work closely with the Government taskforce, consisting of the Office of the Supervising Scientist, the Northern Territory Department of Mines and Energy and Worksafe Northern Territory."
